Ron and Jenelle Alspaugh were able to get their four children evacuated from the house in the early hours of Dec. 26 with the only possessions saved being a few family photographs. According to the Oconto fire chief, the fire originated on the east side of the home and engulfed the house quickly. The family got out through a south door. Family, friends and neighbors have since come to the rescue donating clothes, furniture, food and other items that the Alspaugh family lost in the fire.—reported in the Custer County Chief.
